
I. Instruction to Bidders (ITB)

1. NND invites Request for Proposals (RFP) through e-procurement portal for **Mechanized Sweeping of Roads for Solid Waste Management Under Swachh Bharat Mission/NCAP** as per details given in this documents as per Uttarakhand Procurement Rules - 2017 and subsequent revisions.
2. **Background of the project** – Nagar Nigam Dehradun (hereinafter referred to as “NND” or “the Authority”), is capital city and biggest ULB of Uttarakhand which attract tourist in huge numbers. The existing population of the NND is approximately 12 Lacs having 100 municipal wards spread in approximately 200 sq. km. NND delivers waste management and sanitation services in its jurisdiction.
Sanitation is one of the most important core activities of ULBs, of which road sweeping is an important aspect. With amount of dust generated by construction activities and vehicular movement along with litter generated through commercial activities, it becomes difficult to clean vast stretches of road on daily basis manually. Moreover, due to heavy traffic, it is not desirable to deploy vast number of sweepers in the daytime. Hence NND plans an effective mechanized sweeping of roads to achieve targets of cleanliness and dust pollution reduction. NND is looking for an agency for a period of one year that will help in ensuring effective compliances w.r.t. above-mentioned activity and contribute in building the city image as Green and Swachh (Hygiene) City.
3. **Objective:** The purpose of this project would be to create an efficient and effective road cleaning mechanism in NND, with the following objectives:
 - a. To make NND litter and dust free city
 - b. To ensure an integrated cleaning solution for roads
 - c. To improve the existing standards of public health and environmental quality by establishing efficient mechanism for road cleaning
 - d. To improve the productivity of man, materials and equipment through introduction of GIS based technology & its monitoring system.

- e. To ensure effective redressal of road sweeping related complaints again through the GIS technology.
- f. To achieve mechanized road sweeping of approximately 80 kms stretch of roads on daily basis in NND jurisdiction. The private operator will be responsible for Operation and Maintenance of 02 nos. road sweeping machines as per condition given in this RFP document.

4. **Scope of work:**

- a) The Roads proposed under this contract is attached as **Annexure -1**.
- b) The specification of Road Sweeping Machines required by NND to be used by the contractor during contract period is attached as **Annexure - 2**.
- c) Providing 02 nos. Road Sweeping Machines as per the specification given in the RFP document and daily operation and maintenance of these road sweeping machines for complete duration of the contract
- d) Mechanized Street/road sweeping including Street level collection of Municipal Solid Waste and litter picking from designated road manually/mechanized in Area/roads as designated by NND
- e) The successful bidder shall pick, remove and dispose of the small size loose materials, debris, or small size rubbish deposited on/or along roads, curb channels, footpath by mechanical sweepers. If any small dead animals (such as dogs, cats etc.) and larger dead animals (such as cows, horses etc.) are found on these roads and in the vicinity area under contract to NND, these are to be lifted and transported off by the NND to the designated site upon information received from Contractor.
- f) Swept roads shall be kept litter and dust free during the next day operation hours, from entire wall-to-wall basis. Sweeping of Roads/ Streets/ Lanes would include Bitumen, Pakka, Footpath, Ramps and kuccha portions including sides – Corner to corner.
- g) Small vehicles (as per requirement) and manpower including drivers for small vehicles for litter picking shall be provided by the contractor. Transportation of the collected waste/dust/dirt in these closed vehicles to designated spot as directed by the NND shall be done by the contractor at no extra cost.
- h) Procure, provide, and maintain necessary tools, equipment machinery, manpower, fuel and vehicles for mechanized road sweeping.
- i) NND is not purchasing the road sweeping machines. Contractor has to bring their own 02 road sweeping machines. Road sweeping through these Mechanical Sweeper shall be done on designated roads as instructed by NND officials.
- j) All vehicles should have GPS system fitted in it. It will be responsibility of the contractor to keep the GPS system in working condition. Contractor should keep spare GPS system available with them in case of any fault or breakage in GPS system. The monitoring of the complete system will be done by NND. The GPS system shall be integrated with Smart SWM Monitoring system of NND
- k) The attendance of the workers working in the contract shall have to be done on biometric attendance machines. The arrangement of the biometric machines and its operation will have to be done by successful bidder. Contractor should keep spare biometric system available with them in case of any fault or breakage in biometric machines system. The monitoring of the complete system will be done by NND through biometric machines for workers and real time basis by GPRS on vehicles integrated with Smart SWM Monitoring system of NND.
- l) The machines will have to be fitted with front and rear vehicle cameras to record the cleaning work which the selected contractor will integrate with ICCC Dehradun.
- m) The road sweeping shall be done for minimum 80 KMs a day by two machines in 8 Hours shift. However, actual timing may be reduced or extended by Contractor as per the site conditions and







- need of work. The working shall be for 7 days a week, 30 days a month, making a total run of 2400 KMs per month for 02 machines. It shall be performance based contract.
- n) KMs shall be counted as per passes on each road. For ex: on a double lane road, two passes on either side shall be counted twice the length and on a road with central verge, two passes on either side of the road shall be counted independently. The description shall be provided by NND in form of roster to be followed by selected contractor. One pass shall be minimum 3 mtrs, in width
 - o) The daily shift of 8 hours can be divided into two shifts of 4 hours each or as decided by NND in the daily roster plan.
 - p) NND guarantees work for at least 2000 KMs in a month work for 02 road sweeping machines. If NND does not provide minimum 2000 KMs of work for these machines per month, NND shall pay the contractor for minimum 2000 KM work per month. If the contractor is unable to run road sweeping machines for minimum 2000 KMs per month then a penalty of deficit KM shall be levied which will be calculated as (deficit KM multiply by monthly rate quoted divided by 2400), for example the actual KM run is 1800 then penalty shall be (200 Km being deficit KM multiply by the rate quoted per month say Rs. XXXX divided by 2400).
 - q) The payment will be done only for the amount of work done by road sweeping machines.
 - r) During 8 hour working shift per month contractor should clean at least 2400 km sweeping length. In case the contractor does not sweep 2400 km sweeping road length per month, he/she will have to sweep the 2400 km sweeping length using extra hours for which no extra payment will be given.
 - s) If contractor is asked to work more than 2400 KMs in a month with 02 machines, payment shall be made on pro-rata basis of the extra work done. If NND provides extra amount of work which can be only covered with deployment of extra machinery, only pro-rata basis payment for extra KMs will be provided, no extra payment will be made for additional deployment. Conditions regarding work will remain same as detailed in this RFP.
 - t) All roads under the contract shall be cleaned at least twice every week or as directed by NND. The roads shall include footpaths, central verge and rotary on designated routes as directed by NND.
 - u) Contractor may keep extra/spare machine and manpower to perform the work during breakdown/maintenance of machines in use. The extra machine if provided by contractor shall have to be equipped with GPS and connected to the control room. The payment of 02 machines on road will be made.
 - v) Contractor should Procure/maintain/ keep in stock, necessary tools, equipment, machinery, manpower, fuel, spares, brushes etc. for the road sweeping machines in use. No extra payment for these shall be made.
 - w) In the service area, the containers and bulk waste generation points shall be done by NND. Contractor's scope shall be limited to Mechanized Road sweeping and litter picking on designated roads as directed by NND
 - x) The contractor shall deploy requisite trained staff (ideally 10-12 with every vehicle, as per need) for manual litter picking from designated routes. The contractor shall deploy 1 helper with each road sweeping machine.
 - y) For any accident, any injury or physical harm to any person in caused by operations, the contractor shall be solely responsible for it and shall bear all the cost associated with such eventualities.
 - z) Contractor shall have to provide Road Sweeping Machines with all consumables and spares and shall include the following: - (1) Routine Maintenance of Machine, including replacement of Filter for Hydraulic Oil, Engine Oil etc. (2) All Consumables such as brushes, Suction Blowers


- etc. (3) Routine and major repairs of machine including supply of spares and replacement of batteries and tyres. (4) Provide Diesel and Engine Oil, Hydraulic Oil as per actual requirement.
- aa) Replacement of consumables shall be done on time. If consumables are not replaced timely and as per industry standards, leading to adverse performance, it may lead to NND not counting the km. coverage for the purpose of billing.
- bb) Sweeping will be carried out on clear and level metalled /C.C. roads.
- cc) If required, NND may ask the contractor to work in two shifts or during night. Contractor shall have to follow the directions of NND.
- dd) Staff employed by the contractor should be well behaved, polite & courteous. Any written complaint against staff on behavior shall be taken very seriously and such staff should be removed by the contractor immediately from the site and arrange replacement for the same failing which the Officer-in-Charge may impose penalty.
- ee) Considering Weekly Off, National Holidays, Water logging due to persistent rain, period for schedule Maintenance of machineries, etc. sweeping operation of designated areas with all these 02 NOs of Sweeper machines have to be ensured for Minimum 280 working days in a calendar year or up to 26 working days a month for each sweeper machine.
- ff) During rainy season the contractor may have to deploy additional manpower to clean the roads, further additional machine hours may be required to be deployed by contractor for which no additional payment will be made.
- gg) NND may change the roads as per requirement of NND. List of roads given in Annexure 1 is indicative which may be changed.
- hh) The speed of the machine while sweeping the road shall not be more than 10 km/hr. If it is observed that speed of the sweeper machines while sweeping the road exceeds the given limit resulting in poor sweeping efficiency, penalty as mentioned in the penalty clause section shall be deducted from the Contractors Running Bill.
- ii) NND will provide date wise and road wise roster for cleaning of roads. Selected Contractor will have to follow the roster as provided by NND for road sweeping works


Ensure other necessary legal compliances:

- a) The selected bidder needs to ensure all operations in an environmentally safe and hygiene manner. There should not be any action that is indicated as in-appropriate and negatively evaluated by the NND.
- b) The selected bidder shall at all times indemnify the NND against all claims, damages or compensation under the provisions not just limited to below rules, acts & order, passed by any prescribed authority for rendering such services:
- Environment Protection Act & Rules, made thereunder
 - Swachh Bharat Mission 2.0 Guidelines & Garbage Free City (Star Rating Protocol)
 - Payment of Wages Act, 1936
 - Employers Liability Act, 1938
 - The Workmen's Compensation Act, 1923
 - Industrial Dispute Act, 1947
 - Indian Factories Act, 1948
 - Motor Vehicle Act, 1988 & Emission Norms.
 - Uttarakhand minimum wages rules/ orders (if any)
 - Any other law applicable.

NND's Scope:

- a) NND shall arrange for and provide the following on free of cost basis: (1) Parking and workshop space (2) Monitoring and connectivity to NND hardware

- b) The staff of Health Department of NND shall super-wise and monitor the Contractor's work and services as per the direction of the Competent Authority at all times and notifies the Contractor of any defects found/identified in operation and service level during inspection. Such inspection/checking shall not affect the Contractor's responsibilities. The Contractor shall have to correct a defect and improve service level within the time specified.

Contractor's Responsibilities:

- a) The Contractor shall not modify or alter any operations and timings without prior permission of the Competent Authority.
- b) The Contractor shall carry out his operations, perform work and provide services so as not to interfere unnecessarily or improperly with the convenience of the public.
- c) Shall be fully responsible for carrying out the operations in a safe and secure manner, consistent with the law of the land, laws and regulations and directives of any Authority and permissions.
- d) The milometer of machines should always be in working condition and shall be calibrated by the authorized/approved lab whenever required.
- e) The Contractor shall take all necessary precautions to prevent any nuisance or inconvenience to the owners, tenants or occupiers of adjacent properties and to the public in general and to prevent any damage to such properties and any pollution of smoke streams and waterways. He shall make good at his cost and to the satisfaction of the NND any damage to roads parts or public property whatsoever caused there on by the contractor. All waste or superfluous material shall be carried away by the contractor without any reservation entirely to the satisfaction of the NND.
- f) The Contractor shall be responsible for the safety of all his activities & his personnel deployed for performing the work and providing services under this contract and shall be absolutely and solely responsible for any and all kinds of injuries or damages to person and property of any description whatever may be caused by or result from the operations carried out, whether these may have been carried out skillfully and carefully and strictly in conformity with the provisions of the specifications or not.
- g) Procurement of spares, accessories, tyres, tubes, hydraulic oil, lubricants, diesel, petrol etc. for day to day running, operation and maintenance of transportation vehicles and equipment's shall be borne by the Contractor.
- h) Dress for manpower: Successful Contractor shall provide uniforms, safety gears, mobile facilities etc. to operator & attendants
- Provision of uniforms – As per requirement
 - Provision of Helmets – As per requirement
 - Provision of mask – As per requirement
 - Safety shoes – As per requirement

Payment Terms: The payment shall be done on monthly basis, applicable Taxes as per rules shall be deducted and penalties if any shall be deducted.

5. Qualification criteria:

- Should be a legal entity as per Indian Law. JVs / Consortiums are not allowed.
- Should have a valid GST registration.
- Should have minimum 3 years old EPF and ESIC registration
- Should have submitted Bid Document Fees (Rs. Ten Thousand+18% GST)
- Should have submitted Earnest Money Deposit (Rs. Ten Lakhs only)
- The bidder should not have been black listed as on the last date of proposal submission by any Ministry / Department / under taking of Government of India or any State or Union Territory Administration.

- vii) Should have achieved an Average Annual Turnover during FY 2019-20, 2020-21 & 2021-22 of not less than Rs. 10 crores.
- viii) Should have a net worth of Rs. 100 Lakhs minimum (as on 31st March 2023)
- ix) A Power of Attorney for signing of proposal needs to be furnished in favor of the Authorized Signatory as per format provided in Annexure – 9.
- x) Affidavit as per format provided in Annexure – 11.
- xi) **Past performance:**
- Contractor must have work order and experience of at least three years of successful working of Operation and Maintenance of minimum 02 (Two) Road Sweeping Machines in any ULB in India.
 - Work orders and completion certificate (or proofs) of single or more number of machines (minimum three years' duration of working) shall be added to meet the eligibility criteria.
 - The amount of each such eligible works shall not be less than INR 1 crores per annum.
 - Every work order/completion certificate shall be treated as single job and more than one work order joined together (back-to back work) to fulfill qualification criteria shall not be considered.
6. The Bidders should submit along with the proposal, all relevant documents to establish their eligibility and also for meeting Qualification Criteria.
7. Due diligence by bidders – bidders are encouraged to inform themselves fully about the assignment and the local conditions before submitting the bid by visiting project sites. It would be deemed that before submitting the proposal, the bidder has made a complete and careful examination of terms and conditions/requirements, and other information set forth in this RFP. Received all such information as it has requested from NND.

- (v) The Successful Service Provider's Earnest Money will be returned, without any interest, upon the signing of the Contract Agreement and furnishing the Performance Security in accordance with the provisions thereof.
- (vi) The Earnest Money shall be forfeited in the following cases:
- (a) If the Bidder withdraws its proposal during the interval between the last date for proposal submission and expiration of the proposal Validity Period; and
- (b) If the Successful Bidder fails to provide the Performance Security within the stipulated time or any extension thereof provided by NND.

10. Proposal Preparation Cost:

- (i) The Bidders shall be responsible for all the costs associated with the preparation of its proposal and its participation in the bidding process. NND will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of bidding.
- (ii) Site inspections and visits to the site and related costs to the work. It is desirable that each bidder submits proposals after due visiting the site.

12. Amendment of Proposal:

- (i) At any time prior to the proposal due date, NND may, for any reason, whether at its own initiative or in response to clarifications requested by a Service Provider, modify the proposal through Addendum / Corrigendum which will be posted on the website: www.uktenders.gov.in only.
- (ii) In order to afford Bidders reasonable time in which to take an Addendum into account, or for any other reason, NND may, at its own discretion, extend the proposal due date.

13. Validity of Proposal:

- (i) The proposal shall be valid for not less than 120 (One hundred twenty) days from the last date for proposal submission (but excluding the day of proposal submission). Proposals of lesser validity shall be summarily rejected as non-responsive.
- (ii) Prior to expiry of the original Proposal Validity Period, NND may request that the Bidders extend the period of validity for a specified additional period. A Bidders may refuse the request without forfeiting its Earnest Money. The proposal of any Bidders refusing to extend the Earnest Money shall be returned and shall not be included in the further proposal process. A Bidders agreeing to the request of extending the Earnest Money will not be allowed to modify its proposal, but would be required to extend the validity of its Earnest Money for the period of extension.

14. Pre-Proposal Meeting:

20. Conditional proposal shall not be considered. Any proposal found to contain conditions attached, shall be rejected.

21. Proposal Opening:

- (i) Bidders representatives who choose to be present may attend the proposal opening.
- (ii) If the office happens to be closed on pre-proposal meeting or proposal opening day, same stands postponed to the next working day without any change in time or venue. **However, there will be no change in Proposal submission date on e-portal, unless it is also extended.**

22. Confidentiality:



- (vi) The Financial Bids of technically qualified Bidders will be opened on the prescribed date in the presence of Bidders' representatives.
- (vii) Any conditional bid would be rejected
- (viii) Proposals shall be deemed to be under consideration immediately after they are opened and until such time NND makes official intimation of award/ rejection to the Bidders. - (iii) The Performance security shall be forfeited and en-cashed in the following cases:
- If the Consultant withdraws midway during the work completion, or
 - Any other act or acts of the Consultant which renders the work un-operational and Nagar Nigam, Dehradun establishes sufficient reasons to forfeit the Performance Security.

- c) Any legal non-compliance noticed by NND officials: Rs. 1000/- per non-compliance as identified by the NND officials, apart from the above indicated penalty points.
- d) If it is observed that sweeper machines/vehicles(tanker/tractor) deployed for dedicated sweeping operation of designated areas is used elsewhere (other than NND) for any other private agency/other application, a penalty of Rs. 10000 will be imposed

38. Dispute Resolution:

- c. The cost of arbitration shall be borne by both the parties in equal proportion. Arbitration proceedings will be held at Dehradun only.

39. **Jurisdiction of Court:** The courts at Dehradun shall have the exclusive jurisdiction to try all disputes, if any, arising out of the agreement between the parties.

40. **Termination Clause:** Termination clause on the bidder will be applied accordingly mentioned below:

- a) NND without prejudice to any other remedy for breach of contract, by notice of default sent to the agency, may terminate the contract in whole or part.
- b) If the agency fails to deliver any or all the services mentioned in scope of work within the time period specified in the contract or within extension thereof granted by NND.

CONDITIONS OF CONTRACT

1. Definitions

- 1.1 In this Contract, the following terms shall be interpreted as indicated:
- (a) "The Contract" means the agreement entered into between the NND and the Service Provider, as recorded in the Contract Form signed by the parties, including all the attachments and appendices thereto and all documents incorporated by reference therein;
 - (b) "The Contract Price" means the fees payable by the Service Provider under the Contract for the full and proper performance of its contractual obligations;
 - (c) "Services" means services required to be provided by the Service Provider covered under the Contract;
- 1.2 The Service Provider shall permit NND to inspect the Service Provider's accounts and records relating to the performance of the Service Provider and to have them audited by independent auditors appointed by NND, if so decided.

2. Indemnity

- 2.1 The Service Provider shall undertake an insurance cover for an assured sum equivalent to the Contract Value including GST against third party liability.
- 2.2 In addition, Service Provider shall indemnify NND against all third-party claims arising out of this Contract; and any legal and financial liabilities arising out of negligence or otherwise of the Service Provider's personnel.
- 2.3 The Service Provider shall take all other appropriate insurance covers to protect its own property and employees.
- 2.4 The Service Provider shall further insure for appropriate sum the users of its services as required under relevant Law of the State or India.

3. Compliance to Statutes and Safety Standards:

- 3.1 The Service Provider shall comply with all applicable statutory provisions including guidelines issued by NGT or any other authority/ies with regard to environment protection, safety of the users and general public during the operation by the Service Provider.
- 3.2 The Service Provider shall comply with all applicable statutory provisions with regard to Minimum Wages Act, PF, ESI, etc., for the personnel employed.
- 3.3 The Service Provider has to register itself in Uttarakhand State for remittance of GST; if not registered earlier before commencement of services, if required under relevant law.

4. Payment:

- 4.1 The payment due to Service Provider shall be paid on a monthly basis for the services rendered during the previous calendar month.
- 4.2 The payment shall be made within 30 days from the date of submission of invoice with all the supporting documents required / acceptable to NND duly verified and approved by the designated officer.

5. Commencement of Services:

The Service Provider shall provide all the services agreed upon within 15 (fifteen) days from Signing of the Contract.

6. Inspection and Acceptance:

In accordance with SWM Rules, 2016 and other relevant rules and guidelines in effect.

7. Period of Contract:

The Contract Period for "the Project" shall commence from COD (Commercial Operation Date) and extend for a period of 3 (Three) years from such date (the "Contract Period") and during which the Operator is authorized to implement the Project in accordance with the provisions hereof. For avoidance

of doubt, the Contract Period shall not include Implementation Period (sixty days). However, the said Contract Period may be extended for one year pursuant to the mutual agreement between both the parties.

7.1 It is hereby made clear that:

12. Representations and Warranty:

Fraud and Corrupt Practices
